ANY SUCH REQUEST WILL NOT BE EFFECTIVE UNLESS APPROVED IN WRITING. PLEASE PROVIDE AN E-MAIL ADDRESS IF POSSIBLE SO THAT WE CAN RETURN THE FORM TO YOU IN A TIMELY MANNER. THE FAILURE OF A STUDENT ATHLETE TO FOLLOW TEAM RULES REGARDING TRANSPORTATION AND/OR ARRIVING AND DEPARTING FROM ATHLETIC EVENTS IN A TIMELY MANNER MAY RESULT IN SUSPENSION FROM PLAY OR OTHER DISCIPLINARY ACTION. YOU ALSO ACKNOWLEDGE AND AGREE THAT BY MAKING THIS REQUEST YOU HAVE ACCEPTED SOLE RESPONSIBILITY FOR THE TRANSPORTATION OF YOUR CHILD TO/FROM THE EVENT AND RELEASE THE DISTRICT FROM ANY CLAIMS OF LEGAL LIABILITY RELATING TO SUCH TRANSPORTATION.
